- You take the dollar amount and reduce it by your % of impairment
- For example, with a chart dollar amount of \$128,533.86 and a 5% impairment – you need to multiply  $.05 \times \$128,533.86 = \$6,426.69$  settlement award. 10% impairment  $.10 \times \$128,533.86 = \$12,853.38$  ect.
